President's Profile

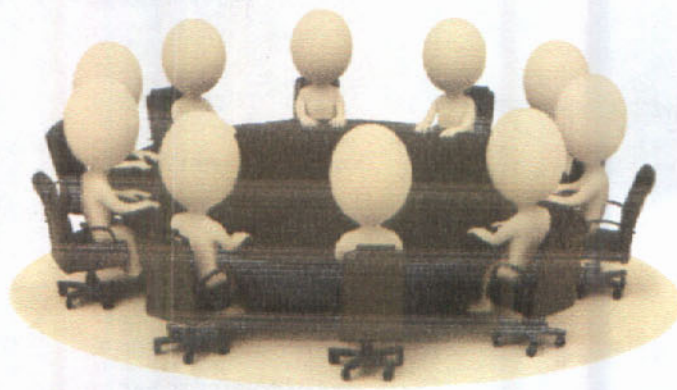
